LENGTH OF COURSE

VCE VM student attend for a half day per week (Feb-Nov) over two years. External students enrol through their home school.

ASSESSMENT

The assessment involves a variety of methods including practical observations of work performance and evidencing written questions. The assessment of overall competence will be undertaken by a qualified assessor and students' competence judged using all the qualification's criteria.

Students will be given a fair and adequate assessment process that includes multiple opportunities to demonstrate competency.

BENEFITS OF TRAINING

The certificate gives students the knowledge and skills to enhance their employment prospects in the sport and recreation industries. Because it has a scored assessment for ATAR purposes, it can be one of the four main VCE subjects or provide a 10% contribution as the fifth subject.
